Sealed quotation/offer in the prescribed format is invited from the advertising agencies/business organizations/Govt. organization/Public/Private bodies/individuals to supply advertisement for thermal paper rolls to be printed on the back side of the paper roll ticket.

OSRTC has introduced ETMs (Electronic Ticketing Machines) in all routes . At present about 50,000 nos of Paper Rolls are required per year for ETMs.

The scope of the work is as follows:

1. The paper roll ticket size is 55mm X 57mm (LXB).
2. The length of paper roll is 15.00 Metres.
3. The bidder will supply the Advertisement in JPG format for printing in the back side of paper rolls.
4. G.S.M.- 50 to 60 quality thermal paper rolls .
5. The front side of ticket is reserved for ticket data. There shall be no advertisement on the front side. Advertisement will be there on the back side of the ticket.
6. The agreement shall be valid for one year from the date of award of order.
7. The bidder shall pay the total cost of the 50,000 paper rolls as per rate fixed.
8. The bidder shall quote the amount to be paid to corporation for each paper roll over and above the cost of paper roll.
9. Application from should be accompanied by a Demand Draft amounting to Rs.1000/- (Rupees one thousand) only which is nonrefundable.

The sealed quotation/offer should reach in this office latest by 3.00 P.M. of 26.11.2018. The sealed quotations/offers will be opened at 4.00P.M. of 26.11.2018 in the office chamber of General Manager (Admn).
