

TERMS AND CONDITIONS OF TENDER FOR DISPLAY OF ADVERTISEMENT OVER 12 SQFT. SPACE IN THE REAR SIDE OF OSRTC BUSES AND 02 SQFT. SPACE IN THE BACKSIDE OF DRIVER'S CABIN IN 325 NUMBERS OF OSRTC ONROAD VEHICLES VIDE TENDER NOTICE NO. 4358 DT.31.3.2018

1. Licence shall be issued for display of advertisement on 325 nos. of OSRTC onroad Bus bodies as mentioned in the aforesaid tender notice to individual person/Body Corporate/Company for a period of one year as mentioned in the tender notice.
2. The complete sealed tender papers as per the proforma enclosed, along with other required papers/documents shall be received through Registered/Speed post only by the General Manager(Admn.) OSRTC, Bhubaneswar, on or before **09.04.2018 up to 3.00 PM.** after which no tender papers shall be received. The sealed tenders shall be opened on **10.04.2018 at 4.00 PM.**

Submission of tender papers through any other modes except Registered Post & Speed Post shall not be accepted and shall be summarily rejected.
3. Envelope containing the tender papers must be super scribed "**TENDER FOR DISPLAY OF ADVERTISEMENT OVER THE BUS BODY OF OSRTC**".
4. The selected bidder shall deposit the annual license fee in advance before execution of the agreement.
5. The full amount of security in shape of Bank Draft of Rs. 5,00,000/- (Rupees Five lakhs) only & EMD amount of Rs.10,000/- (Rupees Ten thousand) only are to be submitted at the time of submission of Tender papers by the tenderer, failing which the tender paper shall be treated as rejected. The Security/EMD amount so deposited shall carry no interest.
6. An agreement shall be executed by the selected bidder in the manner as prescribed by the OSRTC reserving the right of OSRTC to alter and to amend the condition of agreement at any time considered expedient.
7. The successful bidder shall be provided about 325 numbers of buses (Hi-Comf./Hi-Tech./LCV buses) for display of advertisements over the approved space.
8. The successful bidder shall display advertisement over 12 sqft. of area at the rear side of each bus and 02 sqft. in the backside of driver's cabin.
