

These can be purchased on any working days during office hours on payment of **Rs.224/- (Rupees Two hundred twenty-four) only** inclusive of taxes per set of tender paper by cash/bank draft in favour of Accounts Officer, OSRTC, Bhubaneswar. Sale of tender paper will commence **from 04.12.2020 and will continue till 10.12.2020 upto 3.30 P.M.**

Sealed tender will be received by Speed Post/Courier Service **upto 4.30 P.M. of 10.12.2020** and will be opened on the next day at **11.00 A.M.** at Paribahan Bahan Bhawan, Sachivalaya Marg, Bhubaneswar. The intending bidders may also drop their tender papers in the tender box kept in the Corporate Office, Paribahan Bhawan, OSRTC, Bhubaneswar during the time fixed. The Corporation shall have no responsibility for delay in receipt of tender paper.

**TERMS AND CONDITIONS FOR DISPOSAL OF BUILDING MATERIALS AT OSRTC
GARRAGE PREMISES AT BARAMUNDA**

1. Tenderers may inspect the materials during working hours with permission from Depot Manager.
2. Tenderers will not be allowed to pick and choose single item from location.
3. Tender shall be submitted in the tender form annexed.
4. The Tenderer shall quote the rate legibly in words (Block Letters) and numerical to avoid confusion.
5. Tender shall be submitted in sealed cover super-scribing " Tender for disposal of building materials at OSRTC Garrage Premises at Baramunda, Bhubaneswar" without mentioning the name of the Tenderer on the cover.
6. 25% of the bid amount offered for the items will be treated as E.M.D. Even if any Registered Cooperative Society, participate in the tender, they are to furnish EMD @ 25% of the offered value like other Tenderers in shape of D.D.
7. E.M.D. shall be furnished in form of Bank Draft only drawn in favour of the **"Accounts Officer, OSRTC, Bhubaneswar"** and attached to Tender paper.
8. The E.M.D. of 2nd highest tenderer shall not be refunded until the highest tenderer deposit the full bid amount and tender is finally decided in his favour.
9. E.M.D. of all the un-successful Tenderers will be refunded after finalization of tender and obtaining orders from the competent authorities.
10. E.M.D. will be forfeited in the event of the successful Tenderer failing to deposit the balance due amount inclusive applicable taxes within 10 days of issue of notice or failing to obtain a time extension from the General-Manager(A), OSRTC.
11. Successful Tenderers will be intimated through E.mail to deposit the bid value of the materials. In the event if a Tenderer do not deposit the amount due within 10 days of issue of the Notice, the Corporation will be free to dispose the materials to any other party and E.M.D. of the Tenderer shall be liable for forfeiture.

12. The E.M.D. will be usually adjusted against the amount bided against successful Tenderer.
13. On payment of due amount, clearance will be issued by the General-Manager(A) advising the concerned Depot Manager to allow the selected bidder to take delivery of the materials.
14. Taxes statutory levies as applicable at the time of deposit of the full bid value will be borne by the Tenderer for sale of materials.
15. The selected Tenderer shall clear the yard of the materials sold to him within 15 days of issue of clearance certificate by the General Manager(A) failing which ground rent will be charged @ 1% of the disposal for each day of the delay.
16. Ground Rent shall be collected by the concerned Depot Manager provided that the General Manager(A), OSRTC in due consideration on circumstances may extend time for removal of materials to the extent deemed fit and his decision shall be final and binding.
17. The Chairman-cum-Managing Director, OSRTC reserves the right for extending/altering the dates and timing rejecting any or all Tenders without assigning any reasons and his decision shall be final and binding.
