

The Tender shall be of 02 bid system i.e. one Technical bid and another Financial bid and both such bids should be put in separate cover super scribing therein "**Tender Paper for Tyre, Tube and Flaps**"

Intending parties may submit the sealed tender with their best price, terms and conditions for supply of tyres for one year i.e. 2,500 Sets (Approximately) of different sizes during the year 2020.
