DETAILS OF TENDER NOTICE

Sealed tenders are invited from the Manufacturers / Distributors / Authorized Dealers / ASRTU R/C holders having valid GST, PAN and TIN number for empanelment of suppliers for supply of Tread Rubber and Lubricant (Gulf /HPCL/BPCL/Tata make) for a period of one year to OSRTC. The rate offered by the Tenderers are to remain valid during the tender period and under no circumstance revision of price to higher rate will be accepted. The tender paper for Tread Rubber and Lubricant will be available on payment of **Rs. 1,000/- (Rupees One Thousand only)** plus 12% GST only at Central Stores, OSRTC, Badambadi, Cuttack-753009 w.e.f. 03.08.2018 to 08.08.2018. Sale of tender paper will be closed on 08.08.2018 at 5.00 p.m.

The tenderers required to obtain tender paper by Regd. Post may add **Rs. 50/- (Rupees Fifty)** only towards postal charges in addition to the cost of tender paper and send the Demand Draft in favour of Works Engineer, Central Store, OSRTC, Cuttack, payable at Cuttack. However, Corporation will not be responsible for any postal delay.

Intending parties may submit the sealed tender with their best price, terms and conditions for supply of Tread Rubber and Lubricant for a period of one year. The thickness of Tread Rubber supplied by the firm should be as mentioned in the Tender Paper. The minimum running Km. should not be less than 30,000 Kms. for each tread rubber used in the tyre. The performance of Tread Rubber used by OSRTC earlier will be evaluated in terms of cost per Km. and this will be placed before Purchase Committee for selection of source basing on the minimum expenditure incurred. The tenderers should submit the tender paper by Regd. Post to the General Manager (Admn.), OSRTC, Paribahan Bhawan, Sachivalaya Marg, Bhubaneswar- 751 009 or drop the same in the Tender Box kept in the Tender Room on or before 16.08.2018 by 5.00 p.m. and the same will be opened on the next day i.e. 17.08.2018 at 12.30 p.m. in presence of Tenderer or their authorized representatives. The firms participating in the tender is to be enclose E.M.D. amounting to Rs. 60,000/- in shape of Bank Draft in favour of Accounts Officer, OSRTC, Bhubaneswar.
